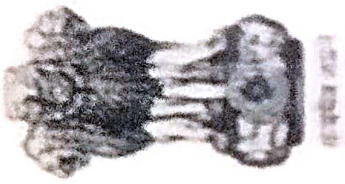

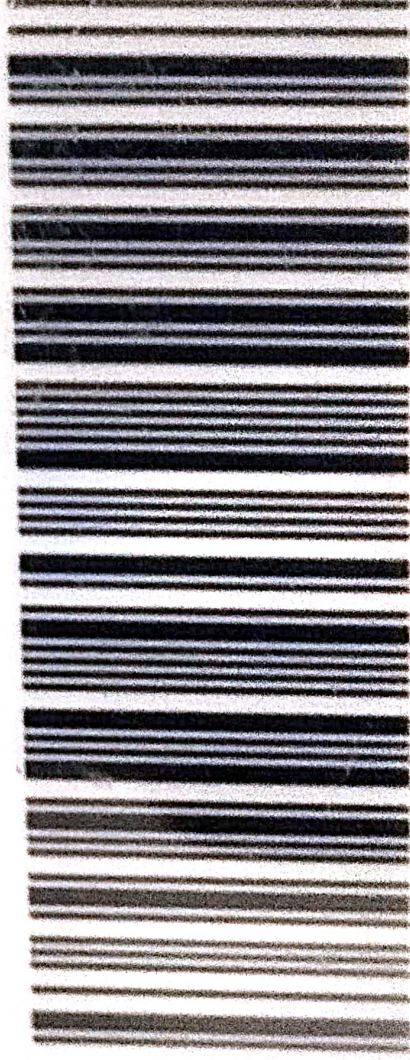

In exercise of power conferred upon the DEE, Assam vide the Govt. letter No. B (3) S 427/2001/3 dated 04/01/2002 and in pursuance of the provision of the Right to Education Act, 2009, advertisement added 11/02/2023, approval of Govt. vide letter No. E-293935/425 dated 06/05/2023, E-298660 and as per the Assam Elementary Education (Prov.) (Amendment) Rules, 2012 and subject to production of medical fitness certificate from concerned Joint Director of Health Services, the following selected candidate is hereby appointed as Assistant Teacher in Lower Primary on purely temporary basis in the Pay Band - 2 (PB-2) @ Rs. 14,000/- to Rs. 70,000/- plus Grade Pay and other allowances as admissible as per "The Assam Service (Revision of Pay) (Amendment) Rules, 2019" under the DIS / DEEO, concerned of Lakhimpur District.

The appointment is purely temporary and is liable to be terminated without assigning any reason thereof, if any kind of fraudulence regarding the credentials submitted by the appointee is established by appropriate authority at any point of time in future.

1. This appointment is issued against existing vacancy with concurrence of the Finance (SHU) Department No. E-296725 dated 06/05/2023, communicated in File No. E-293935 dated 06/05/2023.

2. The appointee will have to furnish an undertaking along with the joining report as prescribed in the Finance (Budget) Department letter No. BW-3/2003/Pt-II/1 dated 25/01/2005 for "New Pension Rules". The content of the undertaking is as follows:

3. The appointee will also have to furnish a notarized undertaking as per the provision laid down in the Govt. OM vide No. ABP. 78/2021-01 dated 18/11/2021, in place of the Police Verification Report.

It is further instructed that without the above undertaking at the time of joining, the joining report shall not be accepted.

4. The appointee also have to furnish an undertaking at the time of joining as "I, _____, appointed as _____ in _____ Department of Government of Assam do hereby undertake that, neither I nor any member of my family is currently availing benefits under Oranodoi scheme."

5. The appointee who is working as contractual teacher under the SSA or working in any other Govt./Govt. undertaking Department must tender his/ her resignation before joining in the new assignment. If established that the candidate has not tendered his/ her resignation before joining in the new assignment, the appointment will stand cancelled automatically without assigning any reasons thereof.

6. The appointee who is appointed as Assistant Teacher of LP School on the basis of qualification of Bachelor of Education (B.Ed.) shall mandatorily undergo a Six-Month Bridge Course in Elementary Education recognized by the National Council for Teacher Education (NCTE) within two years of the appointment as regular teacher. This is in conformity with the Notification No. NCTE-Regl 012/16/2018 Dated 28/06/2018 of the NCTE; otherwise, the appointment will stand cancelled automatically without assigning any reason thereof.

No person having more than two living children on or after 01/01/2021 from a single or multiple partners shall be eligible for appointment as per the Govt. policy on Small Family Norms, the Guidelines contained in the Notification No. ABP.69/2019/17 dated 06/11/2019 and No. ABP.69/2019/18 dated 16/11/2019.

10. The appointment made vide this order shall be subject to outcome of writ petition No. WPC/No. 1615/2023 Banjit Chutia & 9 others -vs- State of Assam and/or further order of the Hon'ble Gauhati High Court.

11. The appointees shall have to join in their respective place of posting from 1st June to 15th June, 2023 positively without fail.

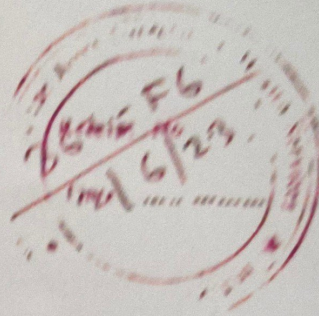





MEMORANDUM

The undersigned hereby offers to Mr. **Senapati Basumatary** Son of Sh. **Durna Basumatary** a post of Constable (General Duty) in the minimum pay of Rs. 21700-69100/- in the Pay Matrix (Level-3) in Sashastra Seema Bal. He will also be entitled to draw other allowances, at the rates as admissible to Central Govt. employees, subject to the conditions as laid down in the rules and orders governing the grant of such allowances in the Force from time to time.

2. The terms and conditions of appointment are as follows:-

- i. On joining the Force, he/she will be governed by the Sashastra Seema Bal Act 2007 & Rules 2009, manuals & other rules/orders as issued and amended from time to time by the Government.
- ii. The appointment is purely temporary but likely to continue. He/she will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority as prescribed under SSB Rules may, for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may during the period of probation, terminate his services without assigning reasons. His/her permanent appointment to the post, however, will depend upon various factors governing terms of permanent appointment to such post in force at that time.
- iii. His/her services on being a temporary Government servant shall be liable to termination at any time by a notice in writing given either by him to the appointing authority or by the appointing authority to him. The period of notice shall be one month; provided that the services may be terminated forthwith and on such termination he/she shall be entitled to claim a sum equivalent to the amount of pay plus allowances for the period of the notice at the same rates at which he/she was drawing then immediately before the termination of his/her services or, as the case may be, for the period by which such notice falls short of one month.
- iv. The competent authority as prescribed under SSB Rules may, having regard to the special circumstances of any case, permit him/her to resign from the force before completing the term of the engagement: provided that while granting such permission the competent authority as prescribed may, require him/her to refund to the Government such amount as would constitute the cost of training given to him/her or three months pay and allowances, whichever is higher. Provided further that he/she on tendering resignation, for accepting a job under the Central or State Governments and local bodies, after having been granted cadre clearance for the same or who has completed ten years of service shall not be required to refund the sum as provided here in above.
- v. On appointment he/she shall be liable to serve in any part of India as well as outside India.
- vi. He/she will be governed under New Contributory Pension Scheme for pensionary benefit effective from 01/01/2004.
- vii. He/She will have to qualify "Basic Recruit Training Course" being conducted by Sashastra Seema Bal within a period of two years from the date of appointment. Not more than two chances will be given to qualifying Basic Recruit Training Course failing which his/her services shall be liable to be terminated.
- viii. He/she will have to undergo various training courses, as may be prescribed, from time to time.
- ix. He/she will not be entitled to any Traveling Allowance/Dearness Allowance for joining on his/her first appointment.
- x. He/She should bring a Certificate from the local administrative authorities like 1st Class Magistrate/Sub-Divisional Magistrate / Tehsildar or any Officer superior to them in the State/Central Government, regarding his/her character and antecedents (as per format enclosed), which should have not been issued before six months of date of joining.
- xi. The verification of Character and Antecedents would be carried out immediately on joining from the concerned District Administration. In the event of furnishing false or incorrect information at the time of appointment in the service, his/her service is liable to be terminated as per the provisions of SSB Act and Rules. Moreover, if any facts or statement mentioned by the candidate in the attestation form being found false or incorrect or any adverse finding is reported against him or her, the individual is also liable for disciplinary action under the provisions of SSB Act and Rules.
- xii. He/She has been selected against the vacancy of ST category. The appointment is provisional and is subject to verification of Schedule Caste/Schedule Tribe/OBC Certificate (if applicable). If the verification reveals that the claim belonging to Scheduled Caste/Schedules Tribe or OBC, as the case may be, is found false, his/her services are liable to be terminated forthwith, without assigning any further reasons or without prejudice to such further action, as may be taken under the provisions of the SSB Act 2007 / Indian Penal Code for production of false certificate.
- xiii. For Other Backward Classes candidates the Community Certificate should invariably be issued by the designated authority only. If on verification it is revealed that his/her claim of belonging to Other Backward Classes and not belonging to Creamy Layer is false, his/her services will be terminated forthwith without assigning any further reasons or without prejudice to such further action as may be taken under the provisions of SSB Act 2007/Indian Panel Code for production of false certificate.
- xiv. He/She should bring Verification Roll form (enclosed) obtaining signature with seal on the "Identification Certificate" by any Gazetted Officer mentioned in the certificate at page 4 of Verification Roll.
- xv. woman candidate only: Those woman candidates who appear for joining in pursuance to the "Offer of Appointment" and as a result of tests is found to be pregnant of 12 (twelve) weeks standing or over shall be declared "Temporary Unfit" and her appointment shall be held in abeyance until the confinement is over. She should be re-examined for a fitness certificate six weeks after the date of confinement, subject to the production of a medical certificate of fitness from a registered medical practitioner. Those woman candidates who is found to be pregnant of period less than 12 (twelve) weeks standing will be allowed to join but will not undergo BRTC at the time of her joining. She will report back to her unit in case if join at training centre.

3. The appointment will further be subject to:-

- i. The submission of a declaration about his/her marital status in accordance with the orders in force regarding appointment under Govt. of India that no person, who has more than one spouse living or who having spouse living marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment, enrolment, or employment in the Force. Any person subject to the SSB Act, who contracts or enters into a second marriage during the life time of his/her first spouse shall render himself/herself ineligible for retention in service and may be dismissed, removed or retired from service on ground of unsuitability.  6. He/she is required to submit an undertaking that if any adverse report comes into the notice during the course of Verification of his/her Character and Antecedents through local administration/Police authorities his/her services may be terminated without assigning any reasons.
 7. If any declaration given or information furnished by him/her is found to be false or if he/she is found to have willfully suppressed any material information, his/her services shall be liable to be terminated along with such other action as prescribed in SSB Act 2007 & SSB Rules 2009 or as the Central Government may deem necessary.
 8. If Mr. Senapati Basumatary Son of Sh. Durna Basumatary accepts the offer of appointment for the post of Constable (GD) on the above terms and conditions, he should report at **44 Bn, Narkatiaganj (BR), Bihar** (joining instructions enclosed) along with above documents on **11/10/2023** without fail, failing which his/her candidature will be cancelled.

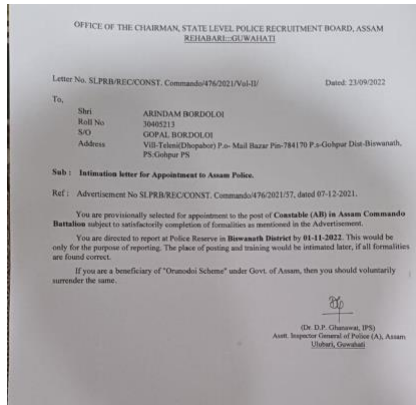

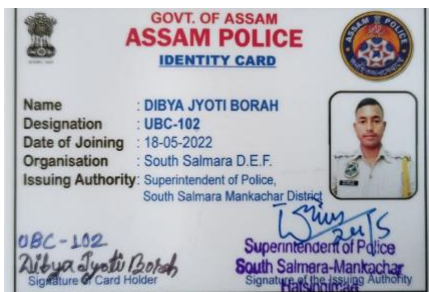
